## DISCRIMINATION/EXTORTION/FALSIFICATION OF RECORDS BY VERIZON FIOS BASED ON CLIENT'S MENTAL ILLNESS

This complaint concerns Discrimination/Extortion/Falsification of Records by Verizon FiOS Based on Client's Mental Illness. It also concerns my filing of a complaint against the employees of FCC disregarding my complaint based on their perception that I am mentally ill; that my complaint is not believable based solely on my status of having a mental illness, eliminating any chance that my complaint will ever be acknowledged. I also allege that based on Verizon's illegal rationalization regarding the belief that I am mentally ill, Verizon has abrogated the Fourteenth Amendment's Equal Protection Clause by not providing me with reasonable accommodations to ensure

Because as yet unknown FCC employees refuse to investigate my complaints, Verizon continues to charge me for a full month of service for the period 1/16/2018 to 2/15/2018, although Verizon provided me with written documentation that my telephone and television accounts would be removed by February 3, 2018.

In this video I connect the cords to the female jacks in Verizon's FiOS box to discover that even though both jacks were off, calls were still being forward to my cell phone's old telephone number, so I changed the telephone number. When I called the old number (718) 277-2162, the call ended up bouncing to the cell phone. That's when I realized that Verizon was cyberstalking me by pretending to forward calls from a phone line that was dead. If the phone service is on, it is because Verizon turned it back on.

This complaint will be forwarded to report FCC's Inspector General because FCC's employees' formed a criminal RICO with Verizon by not evaluating my complaint based on the perception that I have a mental illnes, assisting Verizon in cyberstalking me and abrogating the Fourteenth Amendment's by not providing with equal protection under with law, and not providing me with reasonable accommodations based on the perception that I have a mental illness.




I respectfully ask that you please grant me 30 more days to complete my complaint against Verizon.
